Dear Award Recipient:

Congratulations on being awarded a **Microsoft Instructional Lab Grant** for software licenses valued at **\$18,900**.

We awarded Instructional Lab Grant licenses for software to support courses in existing programs. The awards were made to schools that will use the software to either teach programming or program the applications to solve problems. The highest value was given to schools using programming to integrate multiple products. Other priorities included willingness to share materials through the school's web pages on the Internet, and the number of students reached.

You will receive licenses for the following software:

**50 Copies of Microsoft® Windows® 95**

Per the terms of the award, you must either own or purchase one copy of each application from which you can make the copies. In the case of Microsoft Windows 95 only, we will send you a beta copy over the next week that you can install, and a released copy of the product after the release date of August 24, 1995. You should be able to install the beta copy of Windows 95 in your lab during August and then complete the upgrade upon ship. The award includes maintenance, which means that you may upgrade the software covered by this grant through June 30, 1996. To upgrade, you can purchase one package and make the necessary copies. Microsoft will send you a separate renewal letter allowing you to upgrade your licenses from July 1 1996 through June 30, 1997, provided that you maintained the course syllabi mentioned below at your web site through the academic year.

### **Purpose of Program**

We want all award recipients to have a good experience with the program. There have been many different interpretations and questions regarding the requirements of the program. Please keep the following objective in mind as you create course syllabi and other materials:

- To build a faculty community for sharing information, ideas, and materials to support the teaching of programming or that use programming for problem solving activities.

Submitted materials must be usable by other faculty to be recognized as fulfilling the award recipient's obligation. Course syllabi with minimal information and with sections marked TBD will not be considered as acceptable materials. Faculty reading the syllabi need to view the sequence of topics taught, a description of the specific assignments given, and the readings used to support the course.

- **Department** — Department that oversaw submission of the application.
- **Address Information** — Fields include Address 1, Address 2, City, State, Zip. It's important to have a street address or building name for Address 1 or Address 2.
- **Course Number** — The number assigned for course catalog.
- **Added After Grant Program** — Check mark indicates course submitted with syllabi, nor originally submitted with grant proposal. You may substitute courses for those originally submitted. You may also provide additional courses.
- **Course Name** — Should be name that appears in course catalog.
- **Date of Course** — Semester course is offered.
- **Course Department** — Department offering course.

#### Part 2

In addition to the fields that are duplicated from Part 1, you will find the following fields:

- **URL to School** — The URL address to your school's home page.
- **Not Acceptable** — Courses with a check mark indicate that the materials did not meet the criteria specified on a previous page. These materials are either not usable by another person as they are incomplete, or there is no mention of Microsoft software. You are responsible for reviewing your own course materials in this regard.
- **File Name** — File name assigned to the course syllabi. As a convention, please use the prefix for your department along with the course number where possible. We separate materials into a directory unique to your school.
- **Bad File** — A check mark indicates that the file submitted was unreadable. Please either submit a Microsoft Word document, a document with an RTF extension, or a text document. Documents should provide the information requested in SYLLABUS.DOT.
- **URL to Department** — The URL address to your department's home page.
- **URL to Course** — The URL address to course syllabi maintained at your web site.
- **Materials Promised** — List of materials specified in your grant application for availability on the Internet.
